EXECUTIVE SUMMARY

This report (1) confirms that the local elections were conducted in accordance with elections law, guidance and common practice, and to the performance standards set for Returning Officers and (2) provides the election results and sets out the political composition of the Council for the new term.

REPORT DETAILS

1.00	ELECTIONS MANAGEMENT
1.01	This report reports on the conduct and results of the local elections held on 4 th May. The planning and management of the elections is a major undertaking for the Elections Team. Election management is highly procedural, involves a large volume of work in a short and pressurised timescale, and has to be done with precision and accuracy.
1.02	The 2017 combined County Council and Town and Community Councils elections were managed effectively and to a high standard. The elections were conducted in accordance with elections law, guidance and common practice. The performance standards set for Returning Officers continue to be met in full by Flintshire. Our performance is accredited by the Electoral Commission.
1.03	The Returning Officer and Elections Team have evaluated performance and learning from these elections both for sharing with the Electoral Commission for their national evaluative report and for future elections planning.
1.04	The full results for the County Council elections are listed in Appendix 1. The full set of results for the Town and Community Elections are listed on the Council's website:- http://committeemeetings.flintshire.gov.uk/mgElectionResults.aspx?ID=54&RPID=3663355&LLL=0

2.00	RETURNING OFFICER'S COMMENTS
2.01	I would like to express my appreciation for the dedication and professionalism of the Elections and Count Management teams and for the co-operation of all involved in the elections process, including the many local organisations who made their premises available as polling stations and Coleg Cambria for the availability of the Count Centre. Also, for the cooperation of most candidates, agents, political parties and campaign activists for following the advice and guidance given.
2.02	The Elections Team and I have evaluated performance and learning from the elections both for sharing with the Electoral Commission for their national evaluative report, and for future elections planning. Flintshire continues to be held in high regard for its elections management conduct and practice.

3.00	ELECTION RESULTS
3.01	The details of the votes cast for each candidate and the outcome of the election for each electoral division are set out in Appendix 1 of the report. The overall turnout for the election was 38.73% of the electorate. 15,514 postal votes were issued and 10,525 returned.

5.00	RESOURCE IMPLICATIONS
5.01	The local elections budget has been built up through a combination of previous Council elections funds and contributions from previous nationally funded elections which we are entitled to retain. A reserve of £138,000 has been built up going into 2017/18. This will be more than sufficient to meet the balance of the cost of these elections to be paid in 2017/18. Town and Community Councils are yet to be recharged for their financial contribution to the management of the election so there will be some replenishment of the reserve. This is a prudent way of funding the local elections at minimum cost exposure to the Council.

EXECUTIVE SUMMARY

Every year the Council must agree what arrangements it will make to carry out its functions, such as its committee structure and delegation to officers. These matters are set out in Council Procedure Rule 1.1 (vii)-(xiv) and are determined at the Annual Meeting.

The report is split into sections, each one dealing with one decision that needs to be made and the relevant issues to consider. Each section will need to be considered and voted on in turn at the meeting.

In addition, because this year is the start of a new Council term, Council must consider the appointment of a new lay member to the Audit Committee (see separate report) and must approve the process for selecting a town and community representative on the Standards Committee.

This year there are also a number of changes to be made over how the Planning Committee will operate. These changes are required to comply with legislation, which came into force on 5 May 2017.

The Local Government Measure 2011, requiring the Council to establish the Democratic Services Committee, prohibits the allocation to it of functions over and above its statutory remit.
	However other councils in Wales take the view that the statutory remit of the Democratic Services Committee to "review the adequacy of provision by the authority of staff, accommodation and other resources [my emphasis] to discharge democratic services functions" is sufficiently broad to encompass the role fulfilled by the Constitution Committee (overseeing the constitution and co-ordinating the Overview and Scrutiny Committees). It would therefore make sense to incorporate the Constitution Committee into the Democratic Services Committee.
	The Constitution Committee also has the power to make by review and make by-laws on behalf of the Council. The use of by laws is diminishing as new legislation typically gives a power to make orders (rather than by laws) and allocates the function to the executive. Any residual review or passing of by-laws could be handled by Full Council.

- 1.14 For the Audit and Democratic Services Committees, the Local Government (Wales) Measure limits the number of Cabinet Members on each committee to a maximum of one who cannot be the Leader. The Constitution has extended this so that no Cabinet Member may be a member of the Audit Committee.
- There are a total of 157 seats for councillors across all of the Council committees based on the current group membership. The entitlement of each group to seats is set out in the table below. Those seats could be divided across the different committees in a number of possible configurations, and possible lawful configurations will be circulated prior to the meeting.

1.25	The existing Scheme of Delegation provides for an Appointments Committee for first and second tier officers comprising 7 Members. This is not a standing committee and is convened when required by seeking nominations from Group Leaders. In the past it has been usual for Committee Members to be politically balanced including the relevant Cabinet Member. The Council has previously agreed that the Chair or Vice-Chair of the relevant Overview and Scrutiny Committee be one of the Members of the Committee. 	STANDARDS COMMITTEE

If Council wishes it may reappoint the two previous members (Cllrs Woolley and McGuill) but under the legislation they may serve one further term only. EXECUTIVE SUMMARY

Each year, the Independent Remuneration Panel for Wales (IRPW) determines the rates of payment which are to be made to elected and co-opted Members of Welsh local authorities for the following municipal year. Consultation on the proposals for 2017/18 were carried out last autumn. The final report was published in February and sets the levels of payment for Members for 2017/18.

Flintshire, as with other Welsh local authorities, must decide which payment levels it wishes to apply for the Chair and Vice-chair of Council, Cabinet Members and Committee Chairs.(Because the number of senior salaries is limited to 18, not all Committee Chairs are remunerated).

The Council must also publish a schedule showing who receives what level of payment. A further report on the Members' Schedule of Remuneration will therefore need to be made to the meeting of Council on 20th June, once all appointments to senior salary posts have been made.

RECO	MMENDATIONS
1	That County Council decides whether Cabinet Members should be paid at Level 1, (£29,100) or Level 2, (£26,100), both of which are inclusive of the basic salary.
2	That County Council decides whether the Committee Chairs who are paid a senior salary should be paid at Level 1 (£22,100) or Level 2, (£20,100), both of which are inclusive of the basic salary.
3	That County Council decides whether the Chair of Council should be paid at Level 1 (£24,100) Level 2 (£21,600) or Level 3 (£19,100), all of which are inclusive of the basic salary.

That County Council decides whether the Vice-chair of Council should be paid at Level 1 (£28,100) Level 2 (£16,100) or Level 3 (£14,100), all of which are inclusive of the basic salary.

REPORT DETAILS

1.00	EXPLAINING THE SCHEDULE OF REMUNERATION
1.01	The Independent Remuneration Panel for Wales (IRPW) issued its Annual report for 2017/18 in February. The IRPW Annual Report determines what payments can be made to both elected and co-opted Members for 2017/18. Within the report, a number of determinations apply to County Councils, whilst others apply to the Fire & Rescue Authorities, National Park Authorities and Community/Town Councils. This report deals solely with determinations which relate to the County Council.
1.02	Subject to their having signed the declaration of acceptance of office, all elected Members will receive the basic salary of £13, 400 from 8 th May 2017. This is as required in IRPW <u>Determination 1</u> , and is an increase of £100 on the 2016/17 basic salary.
1.03	Positions of responsibility attract a higher rate of remuneration called a "senior salary". There is a limit on how many senior salaries Flintshire can award (18) based on its population (Group B, populations of between 100,000 and 200,000).
1.04	<u>Determination 2</u> relates to the level of senior salaries. There has been no increase in senior salaries, but as each senior salary also includes the basic salary element, there is, in effect, an increase of £100.
1.05	There is provision to pay Cabinet Members at two different levels, reflecting the extent of their responsibilities. Level 1 is £29,100 (inclusive of the basic salary) level 2 is £26,200. Flintshire have previously indicated to IRPW that it would not pay different rates to Cabinet Members and the IRPW have confirmed that no Council has introduced differential payments within Cabinets or to committee chairs. The County Council must make a decision as to which level payment is made at: the current payment was agreed to be level 1 at the last Annual Meeting.
1.06	The payment to Committee Chairs is £22,100 for Level 1 and £20,100 for Level 2. The County Council must make a decision as to which level payment is made at: the current payment was agreed to be level 1 at the last Annual Meeting.
1.07	The payment to the leader of the largest opposition group is £22,100.
1.08	Determination 3 relates to the remuneration of civic heads and deputies (in Flintshire's case, this means the Chair and Vice-chair of Council. These two posts are not included in the 18 payments cap. The IRPW has set three possible levels of salary. It is for each Local Authority to decide at which level it makes payment. As an example, it could be decided that the role of Tudalen 50

	the Chair is such that it warrants payment at level 1, but that the Vice-chair be paid level 3. It would also be possible to pay the chair at level 3 and the Vice-chair at level 1, reflecting the nature of their duties.

	Since this discretion was introduced, Flintshire have always paid Level 2 to both the Chair and Vice-chair. The County Council must make a decision on this .
1.09	<u>Determinations 6 and 7</u> relate to the provision of support to Members, with which Flintshire complies.
1.10	<u>Determination 8</u> states that 'The Panel has determined to include a provision for specific or additional senior salaries that do not fall within the current Remuneration Framework.
1.11	<u>Determination 17</u> reiterates the entitlement of all eligible elected Members to join the Local Government Pension Scheme.
1.12	<u>Determinations 18-23</u> relate to payment of salaries during family absence and now incorporate arrangements for sickness absence of senior salary holders.
1.13	<u>Determinations 38-42</u> relate to payments made to co-opted Members, which are as follows:
	Chair of Standards Committee - £256 for 4 hours and over, £128 up to four hours.
	Ordinary co-opted members of Audit, Standards and Education & Youth Overview & Scrutiny Committee £198 for 4 hours and over, £99 for up to 4 hours.
1.14	<u>Determination 43</u> relates to the renaming of the Carer's Allowance provision to 'Reimbursement of the Costs of Care'. Members of the Council who have caring responsibilities are eligible to have the costs of care reimbursed, subject to conditions, on application to the Democratic Services Manager.

EXECUTIVE SUMMARY

The Local Government (Wales) Measure 2011 requires that the County Council appoints lay members up to one third of the membership of the Audit Committee (with the minimum of one member). At its meeting on 14 February the Council decided to appoint the statutory minimum of one lay member.

The legislation required the Council to take into account any statutory guidance when appointing lay members, no guidance has been published on appointing lay members. The Measure also provides that actions taken by the Audit Committee are invalid if its membership does not comply with the legislation.

RECOMMENDATIONS	
1	The name of the preferred candidate is Sally Ellis.
2	That the Council agrees to the appointment of Sally Ellis as lay member to the Audit Committee, serving a term of 5 years.

REPORT DETAILS

1.00	APPOINTMENT PROCESS
1.01	The role of the lay member on the Audit Committee is similar to that of a councillor, insofar as the person will be required to have oversight of Council functions and processes and to give assurance that the internal control framework is operating properly. The role differs from that of a councillor in at least two important respects: • The lay member has no political affiliation;
	The lay member can be recruited specifically because of potential valuable skills and/or experience within the field.
1.02	Given the sometimes sensitive nature of reports considered by the Audit Committee, it is also essential that any lay person is able to exercise both discretion and diplomacy. The shortlisting and interview process was designed to ensure that any potentially successful candidate possessed all of these qualities.
1.03	Adverts were placed in the Daily Post on 9 March and the Council's website. Attached as Appendix A is an information note sent to those who expressed an interest. In total of 4 applications were received. Candidates were shortlisted by the Chief Officer (Governance), Corporate Finance Manager and Acting Internal Audit Manager using the following criteria:
	 Experience and/or understanding of audit, accounting practice and/or financial procedures Knowledge and/or experience of local government Perceived political and operational independence Has not been a councillor or officer of Flintshire County Council Has not been a councillor or officer of another council
1.04	Council approved a panel to interview candidates consisting of the Chair of Audit, Leader, Chief Officer (Governance) and Corporate Finance Manager. The Chair of Audit was not available for the interviews and so the Vice-Chair of Council took his place. The interviews took place on 8 May and Sally Ellis is recommended for appointment. Attached at Appendix B is a pen portrait of Sally Ellis.

Information about being a lay member of Flintshire's Audit Committee

The Local Government (Wales) Measure 2011 requires the 22 unitary authorities in Wales to each have an Audit Committee and for at least one member of that Audit Committee to be a lay person.

Flintshire County Council has for many years had an Audit Committee. Since 2012 it has consisted of 8 councillors plus 1 lay member. That lay member has made a valuable contribution to the work of the committee and is unable to continue due to work commitments.

The Audit Committee is required by the Local Government Measure to have the following functions:-

- a) To review and scrutinise the authority's financial affairs;
- b) To make reports and recommendations in relation to the authority's financial affairs:
- To review and assess the risk management, internal control and corporate governance and anti-fraud and anti-corruption arrangements of the authority;
- d) To make reports and recommendations to the authority on the adequacy and effectiveness of those arrangements;
- e) To oversee the authority's internal/external audit arrangements;
- Approve (but not direct) internal audit's strategy, plan and monitor performance
- g) Receive the annual report from the Internal Audit Manager and
- h) To review the financial statements prepared by the authority.

The Audit Committee is supported by the senior officers of the Council who attend to present reports and answer questions from Committee members. In the last year there were 7 meetings of the Audit Committee. The diary of meetings is attached below. The agendas and reports to be considered at the meeting are sent out approximately a week in advance of the meeting. The lay person will be entitled to claim £99 for attending each half day meeting. In the event of the meeting lasting over 4 hours, the payment is £198.

Agendas and reports of previous Audit Committee meetings are available on the Council's website (www.flintshire.gov.uk). The successful applicant will receive induction training and training for all Audit Committee members has been arranged for 19 and 22 May (to be confirmed). The 8 Councillor members of the Committee will be known shortly after the Council's annual meeting on 18 May 2017.

It is intended to hold interviews for the appointment of the lay person on 27 April 2017. Applicants will be informed whether or not they have been successful shortly after this date. EXECUTIVE SUMMARY

This report sets out the calendar of meeting s for 2017/2018 and explains the current arrangements for scheduling formal meetings of Council, Cabinet and Committees.

In March 2016 Councillors were asked when they would prefer meetings to be held, and the majority favoured day time. However, it was recognised that the "new" Council should make its own decision on when meetings should be held, which suggests that a further survey should now be held.

However, in terms of our business planning, the Council needs to be able to plan for the whole year. Therefore, a draft schedule of meetings showing morning and evening meetings has been prepared and is attached for Member consideration.

RECO	MMENDATIONS
1	That the attached draft schedule of meetings for 2017/18 be approved for the time being.
2	That the Democratic Services Manager survey Member preferences for when meetings are held. This would be conducted after the August recess, with a view to a report analysing the results being made to the Constitution Committee in October.

REPORT DETAILS

1.00	EXPLAINING THE SCHEDULE OF MEETINGS FOR 2017/18
1.01	Following a decision which was made by the County Council in March 2010, the Schedule of Meetings of Council, Cabinet and Committees has been based on an approximately 10 weeks' cycle.
1.02	Last year, in response to suggestions from some Members that we should broaden the span of when we hold our meetings, the Democratic Services Committee tasked the officers with carrying out a survey of Member opinion. This was carried out in March 2016, amongst the then elected and co-opted members. There was a majority in favour of keeping day time meetings. The schedule of meetings for last year was based on that approach. The dates for all meetings until the August recess this year have previously been agreed by Council.
1.03	It was recognised that the 'new' Council should be able to form its own opinion on this important issue. It is recommended that a further survey be held amongst all Members following the August recess. By then, Members will have an idea of their workload and meeting commitments.
1.04	That being so, a schedule of meetings for 2017/18 has been drafted following the previous model. In terms of planning, this is preferable than leaving things undone. This, if approved, will be used for meeting planning until the survey has been conducted. The Constitution Committee will then have an opportunity to consider the results and make an appropriate recommendation to Council.

2.01	The holding of evening meetings may increase costs as it will be necessary to keep County Hall, or other building where formal meetings are held, open later than the current 7pm close.
