DMc welcomes everyone and opens the meeting with a short period of silent reflection.

Agenda Item 1 - Apologies for Absence

Rosalind Williams (**RW**) (Church in Wales, Diocese of St. Asaph); Cllr Colin Legg (**CL**); Ibad Hussain (**IH**) (Bryn Coch CP School, Mold).

Agenda Item 2 - Declarations of Interest: Code of Local Government Conduct

DMc Members are reminded that they must declare the existence and nature of their declared personal interests.

There were no declarations of interest.

Agenda Item 3 – Minutes of Last Meeting (21st February 2018)

JA Apologies offered for the previous meeting as it coincided with appointment to the committee.

PL Agenda Item 3, Resolution (a) - Estyn have been contacted in regards to the SMSC comment for Ysgol Pen Coch but there has been no direct response. Questions were raised regarding special school status and Estyn's responsibility highlight

when schools are not meeting statutory requirements for Collective Worship for example in the case of Castell Alun High School.

Furthermore, the new inspection framework appears to show a return back to spiritual, moral, social and cultural (SMSC) development in its entirety.

VB Additional guidance has been given to inspectors and there will be a strong focus on self-evaluation for schools moving forward.

PL A response from Philip Blaker, Chief Executive of Qualifications Wales was received 1 February 2018 but additional concerns were raised about the lack of Welsh textbooks.

Regarding the new qualifications, they continue to be in line with those in England regarding parity.

This response was shared with WASACRE but Wrexham SACRE have taken the matter further, focussing on the discussion of an interim qualification in Key Stage 4 Religious Education.

All resources for GCSE are available in English and Welsh.

LO Resources at A-Level however are only available in English.

PL The current specification is in play until 2022 when there will be changes in light of the new curriculum for Wales.

PL Agenda Item 5, Resolution (a) – Clarification that concerns raised were more about Estyn and not Castell Alun High School. Estyn's Mark Campion and Michelle Gosney are keen to ensure there is specific training for inspectors in SMSC and collective worship.

PL Agenda Item 6, Resolutions (a) and (b) - the GCSE data tables have been checked to confirm they are accurate. In addition, the Holywell figure showing no results was correct as no pupils were entered for the examination in 2017. The school began teaching courses in 2017 so pupils will be entered for exams in 2018 which should be reflected in the next set of results.

VB Holywell should be shown as Ysgol Treffynnon in future reports as this is the name of the new Holywell High School, replacing the original in 2016.

PL Agenda Item 7, Resolution (a) – Materials are almost ready and the Flintshire SACRE group will have to agree the next syllabus at the next meeting, more than likely keeping the existing programme until 2022.

PL Agenda Item 8, Resolutions (a) and (b) - Minutes from the 10 November 2017 WASACRE were handed out to the committee and it was reported that at the March meeting there were presentations by Welsh Government on the new curriculum and on teacher training.

Resolutions

- (a) PL report back on discussions regarding the interim qualification.
- (b) The minutes of the last meeting are approved as a true and accurate record.

Agenda Item 4 - Analysis of Inspection Reports

PL The information included in the agenda pack was incorrect.

PL distributes the correct analysis amongst the committee.

PL Inspections for the three schools have all be conducted under the new Estyn Inspection Framework. If there was no comment under a particular heading then it has not been included in the analysis.

PL outlines key analysis from the reports.

PL Responding to a question from HPD, it is confirmed that Ysgol Terrig was inspected and not Terrig nursery as identified in the analysis.

Resolutions

- (a) PL to amend “Cylch Meithrin Terrig, Treuddyn” to “Ysgol Terrig, Treuddyn” in the Analysis of Inspection Reports.
- (b) PL to write to the three school on behalf of the committee to congratulate them on their reports.

Agenda Item 5 – Curriculum for Wales

PL Welsh Government are keen that once the new curriculum is published it will be adopted by all SACRE's.
The information has been emailed out by Welsh Government and comments have been invited.

PL distributes the information amongst the committee and outlines the Humanities AoLE proposals.

The committee divides into five small groups, each looking at one of the progression steps to analyse their content and language.

PL It appears that a group of schools would come together to develop curriculum and act ivies in line with the progression steps.

Comments from the groups include:

- It is positive to see the new curriculum taking shape;

- Some statements appear to be influenced by the speciality of the people who have written them;
- The more advanced steps look good and challenging;
- Difficulty varies in the steps across different topics;
- Language is inconsistent in the Foundation Phase;
- It may be possible to blend areas if considered as a whole;
- The detail may cause apprehension amongst staff.

PL invites the committee to provide any specific or general comments via email by 27 June 2018.

Resolutions

- (a) PL to coordinate a response on behalf of the committee.

Agenda Item 6 - WASACRE

PL distributes the minutes of the last meeting, dated 9 March 2018.

PL Kirsty Williams AM, Cabinet Secretary for Education, has confirmed that Humanists can have full representation on a SACRE provided they meet the required criteria.

HPD There is an opportunity to have wider religious representation on Flintshire SACRE.

PL Rachel Bendall delivered a presentation on teacher training.

IR At primary level, training teachers for one year following them gaining a degree in a specific area seems to be flawed as they teach a broad range of subjects. Primary teachers who train for four years (as opposed to one) covering a variety of subject areas can provide a more rounded and balanced education for children.

PL Michelle Gosney has responsibility with Estyn for Religious Education and humanities. Michelle will provide has been appointed the lead Estyn officer for faith schools a presentation on the thematic review of Religious Education will be delivered at the next meeting.

Flintshire can have up to three representatives at WASACRE meetings, with the next scheduled for 6 July 2018 in Llangefni. Details of the meeting can be found on the WASACRE website.

Foreword

The Role of the Standing Advisory Council for Religious Education:

The principal roles of SACRE are:

- Advising the Local Authority on matters to do with Religious Education and collective worship, or Spiritual and Moral Development;
- Consider applications from Headteachers that their school be released from the statutory requirements for Collective Worship to be wholly or mainly of a broadly Christian character (such applications are known as 'Determinations');
- Require a Local Authority to review its Agreed Syllabus;
- Monitor the provision of RE, collective worship and spiritual, moral, social and cultural development in the schools of the Local Authority;
- Give advice on teacher agreed syllabus RE, including the choice of teacher materials;
- Advising the Local Authority on the provision of training for teachers (in RE);
- Considering complaints about the provision and delivery of RE and collective worship made to the Local Authority.
- To publish an Annual Report on its work.

The Composition of SACRE:

The statutory requirements for the setting up of SACREs require three committees of members:

- Representatives of Christian denominations or other religions and their denominations reflecting the principal religious traditions of the locality;
- Teacher representatives;
- County Council representatives.

There is also the right to co-opt members.

2. Advice Given to the Local Authority

(a) Religious Education:

i. The Agreed Syllabus

Flintshire SACRE adopted the 'National Exemplar Framework for Religious Education for 3-19 year olds' as the Locally Agreed Syllabus for Flintshire in 2008. The framework continues to be the basis of the Agreed Syllabus in Flintshire. The Agreed Syllabus will be reviewed once the findings of the curriculum review are published.

A SACRE's main function is '...to advise the authority upon such matters connected with religious worship in county schools and the religious education to be given in accordance with an agreed syllabus as the authority may refer to the council or as the council may see fit.' Education Reform Act 1988 s.11 (1) (a)

The planning document 'Comprehensive Guide to RE' and 'RE in the Foundation Phase', which complement the Agreed Syllabus, continue to be requested and used by schools.

ii. Standards

Examination results

The SACRE received details of the examination results for 2017. All GCSE full course and short course results relate to pupils that have sat an RE examination and left compulsory Education.

363 pupils sat the full course in 2017 compared to 482 candidates in 2016. The full course results were above the national average, 76.3% compared to 68.3%, and above last year's LA results by 2.6%.

782 pupils sat the short course in 2017, compared to 910 pupils in 2016. The overall A*-C was 43.9%, 4.3% above the national results for all candidates, but a 4.8% decrease on last year's local figures.

In 2017, 36 pupils sat an 'A' level in Religious Studies, compared to 28 pupils in 2016. For Advanced Level, the overall A* – C rate was 72.2% compared to 94.7% in 2016 and 5.9% below the 2016 results.

Inspection Reports

Due to the current Estyn inspection framework there are no subject judgments in the Estyn reports. Instead, members receive information from the reports relating to Estyn's comments of a school's provision of SMSC. See part c Collective Worship - Monitoring provision - Inspection reports.

b. Methods of teaching

The SACRE and the LA have previously provided comprehensive documents and materials in support of the Agreed Syllabus, and these contain advice on methods of teaching and delivery of RE.

No advice has been given to schools regarding methods of teaching in 2017-18.

Choosing teaching resources

The SACRE does not formally advise schools in the matter of purchasing teaching resources, deeming this to be a matter for the schools themselves.

The Lead Practitioner programme, funded by Welsh Government and organised by the local consortium (GwE) have continued to encourage schools to share resources to support the planning and preparation for the current WJEC GCSE specification.

Provision of Initial Teacher Training

It had not been possible during the year to make a visit to or receive a visit from an Initial Teacher Training Institute.

c) Collective Worship

Monitoring provision

Inspection Reports

As part of the process of monitoring, Estyn Inspection Reports are analysed in terms of collective worship, spiritual, moral, social and cultural development (SMSC). These are compiled and noted by SACRE. Letters are sent to schools following the consideration of them in SACRE, commending good practice and offering support as may be necessary.

Members received an analysis of three schools have been inspected under the old framework. Over the year 6 schools' inspection reports were analysed under the current inspection framework.

iii) Guidance Documents

Guidance documents created in previous years continue to be available to schools including 'A Comprehensive Guide to RE' and 'RE in the Foundation Phase'.

A small number of schools have worked collaboratively to develop guidance for all schools in the LA on aspects of monitoring and curriculum planning.

iv) Resources recommended

The guidance documents referred to above contain references to resources valued and recommended or evaluated by serving teachers. In addition, advice is offered in response to specific requests. Also schools are informed of resources through the RE News which is available to all schools electronically, they also have access to the Welsh National Centre for RE resources at Bangor University and also the St Mary's Centre for RE.

Self-evaluation materials continue to be promoted and are available on the REQM website.

The Lead Practitioner for Flintshire continues to facilitate opportunities for RE teachers to share resources relevant for the new WJEC GCSE RE specification.

v) INSET for Collective Worship

No inset has been provided for Collective Worship in the current academic year.

vi) Evaluation of the effectiveness of guidance

No formal evaluation of the original guidance material has been undertaken, but responses from schools to the materials, and comments offered through school visits have indicated how much the schools have valued the materials and used them in planning and enhancing their provision.

vii) Determinations

No Determinations have been made.

3) Other Matters

a) Local

SACRE is continuing to support school to school collaborative groups that will develop curriculum and monitoring resources that will be shared with schools across the LA.

Local primary and secondary schools have been reminded of the requirements of the Locally Agreed syllabus and it continues to be statutory until the Local SACRE confirmed the new requirements in conjunction with the New Curriculum for Wales.

b) National

The development of the new Curriculum for Wales has continued this year and members have been able to discuss and comment on the draft planning documents provided by Welsh Government.

Members continue to receive presentations regarding the implications of the Donaldson Review on Religious Education and the development of the pioneer network.

(i) Estyn:

Inspection Reports on schools were received and analysed, as reported. Members received a presentation on the current Estyn inspection process.

(ii) DFES:

The SACRE has been informed of developments and initiatives undertaken by or through the Department for Education and Skills.

(iii) WASACRE

Members of SACRE and the LA were represented at all the meetings of WASACRE, and received some of the presentations that had been made. SACRE continued to receive reports from representatives attending the meetings of the Association, and also receiving of minutes and papers from WASACRE.

(iv) Complaints

No complaints were received by the SACRE.
