

PROPOSAL: Proposal for 5 no. glamping pods including associated access, parking, bin storage and private treatment plant.

LOCATION: Y Fron Farm, Mountain Road, Cilcain, Mold, Flintshire, CH7 5PB

Thank you for consulting the AONB on this application. The following observations are submitted on behalf of the Joint Committee:

"The site is partially screened from the nearby road and popular walkers parking area by the local topography and existing trees and hedgerows which are to be retained. It will be visible in middle distance views from the higher ground of Moel Famau to the south but, given that the siting is reasonably well-related to the existing farm, it will read in the landscape as part of the larger complex of farm buildings. In this context, the Joint Committee has no objection in principle to this relatively low impact farm diversification scheme which will enhance the tourism offer of the AONB.

On matters of detail, the committee would recommend that if permission is granted it should be subject to a holiday use only condition and a condition to remove the pods and to reinstate the land should the use cease. In addition, a comprehensive landscaping scheme is required including enclosing the site with a traditional native hedge and hedgerow trees to mitigate and break up views of the development, particularly from the south. The colour and finish of the metal cladding will also require careful consideration to ensure it is recessive in the landscape. No details of external lighting have been provided but if any is proposed this must be the minimum necessary and be designed to conserve the AONB's dark sky and nocturnal wildlife. The committee would recommend that a condition should be attached to control external lighting."

I would be grateful if you could take account of the committee's views when deciding this application.



Thank you for consulting the AONB on this amended application. The following *additional* observations are submitted on behalf of the Joint Committee:

"The Joint Committee has no objection to the revised layout and welcomes the additional landscaping shown on the plan. The committee would however suggest that the landscaping scheme would be enhanced if 2/3 additional native hedgerow trees (e.g. Rowan, Field Maple) were planted along the new southern hedge to mitigate and break up views of the development, particularly from Moel Famau to the south."
