Summarised as follows:- Surface water from site will be free to run down the drive directly onto the road adding to flooding problems. Private sewage treatment plant is of a type that has been reported to only just on average satisfy regulations for biological oxygen demand. Will be on occasions where regulations are not satisfied and some not properly treated foul water which will be released into the stream which flows through the application site. Sewerage treatment plant located approximately 19 m from pipe which feeds spring water into neighbouring resident's pond where fish are kept. Concern water could be contaminated if sewerage plant malfunctions. Water from spring is sometimes used a drinkin water.
