Fund History and Overview



Flintshire Community Endowment Fund

- Grants to individuals up to and including the age of 25 years who are currently resident in the
 Local Authority area of Flintshire can apply for up to £200 to support education achievement or to
 support the cost of representing the area of North East Wales in sport or other activities.
- Not for profit organisations working with residents of the Local Authority area of Flintshire can
 apply for grants up to £1,000 for projects focussed on education development and school based
 projects that support health matters and healthy living.

Fund History and Overview



TriPartite Welsh Church Act Fund - Flintshire

- Churches and not for profit organisations working with residents of the Local Authority area of Flintshire can apply for grants up to £1,000 to support the cost of:
 - refurbishment and upkeep of churches, chapels and community/village halls within the county
 - working to address disadvantage to benefit Flintshire residents
 - providing social and recreational activities for Flintshire residents
